



WAMITAB Level 3 Certificate in Principles of Sustainable Resource Management

About this qualification

Learners will develop the knowledge and understanding underpinning work in a broad range of job roles within the waste and resource management industry. This qualification is perfect for existing employees or apprentices that need to understand the underlying principles of sustainable resource management to ensure services are delivered safely, efficiently and to a high standard. This qualification will support career progression from operative to team leader/supervisory level occupation within the waste and resource management industry.

Who is it for?

- Supervisor and team leader
- Apprentices
- Experienced workers that want progress their career

What does this qualification cover?

To achieve this qualification, learners must complete all mandatory units which are designed to ensure learners understand the principles of waste and recycling, identify and classify waste correctly, recognise the importance of environmental protection and can maintain health and safety in the workplace.

- Learners who choose the **General Pathway** will complete units covering topics such as policy, legislation, environmental permitting, systems and technologies used in resource management.
- Learners who choose the **Reuse Pathway** will complete units covering the refurbishment, reuse and transportation of materials in a retail environment. This pathway is used primarily for those seeking employment, or working within the third (not-for-profit) sector; for instance, in charity shops.

What are the entry requirements of this qualification?

This qualification is open entry. This means that learners interested in undertaking the WAMITAB Level 3 Certificate in Principles of Sustainable Resource Management do not require any other qualifications or levels of attainment in order to take this qualification.

What job role could this qualification lead to or support?

This qualification is ideal for people seeking entry to the waste and resource management sector, or those who are already working and planning to progress to a senior job role. It is a flexible qualification that can be tailored to meet the requirements of specific job roles in the sector or within a particular organisation – these job roles include:

- Refuse collection supervisor
- Transfer station supervisor
- Sustainability officer
- Treatment supervisor
- Landfill supervisor
- Materials recycling facility supervisor

People already working in relevant roles could be employed by local authorities, waste management companies or third sector (not-for-profit) organisations. This qualification will support the sector to overcome significant skills gaps as more than two-thirds (69%) of the workforce holds a Level 2 as their highest qualifications (UKCES, 2012).

Funding outside of the Apprenticeship

The profile of the waste and resource management sector is such that many learners will be precluded from undertaking full apprenticeships due to an inability to meet all required elements of the framework; such as functional skills. Skills gaps identified by UKCES (2012) suggest that more than two thirds (69%) of the workforce holds a level 2 as their highest qualification. However, as a standalone qualification this provides required industry specific underpinning knowledge to support employment and professionalism within the waste and resource management sector. Learners who are unable to participate in apprenticeship frameworks should still be offered the chance to achieve vocational qualifications that improve their opportunities for career development in the future.
