



# **WAMITAB Level 2 Certificate in Principles of Sustainable Resource Management**

### About this qualification

Learners will develop the knowledge and skills required to work in a broad range of job roles within the waste and resource management industry. This qualification is ideal for new entrants or apprentices that need to understand the underlying principles of sustainable resource management to ensure services are delivered to a high standard.

#### Who is it for?

- New entrants to the industry
- Long-term unemployed who wish to retrain
- Apprentices
- Experienced workers that want to improve their underpinning knowledge and understanding, or to progress in their career

### What does this qualification cover?

To achieve this qualification, a learner must complete all of the mandatory units (which total 15 credits) and then choose either the General Pathway or the Reuse Pathway.

The mandatory units are designed to ensure learners understand the principles of waste and recycling, identify and classify waste correctly, recognise the importance of environmental protection and can maintain health and safety in the workplace.

- Candidates who choose the **General Pathway** must achieve at least four other units from the General Pathway Optional Group. These units cover: waste management legislation, information management, requirements for transporting waste, waste treatment and street cleansing.
- Candidates who choose the Reuse Pathway must complete all Reuse Mandatory Group Units, at least 4 credits from the Reuse Optional Group 1 and at least 2 credits from Reuse Optional Group 2. Minimum credit value is 19. These units cover: customer service, management systems, procedure and transportation of waste.

### What are the entry requirements of this qualification?

This qualification is open entry. This means that learners interested in undertaking the WAMITAB Level 2 Certificate in Principles of Sustainable Resource Management do not require any other qualifications or levels of attainment in order to take this qualification.

### What job role could this qualification lead to or support?

This qualification is ideal for people seeking entry to the waste and resource management sector, or those who are already working and want to develop their knowledge and understanding to progress their career. It is a flexible qualification that can be tailored to meet the requirements of specific job roles in the sector or within a particular organisation – these job roles include:

- Waste/ recycling operative
- Transfer station operative
- Compost operative

- Household waste recycling operative
- Manual/mechanical street cleaner
- Waste/ recycling collection driver

Employers within the sector include local authorities, waste management companies or third sector (not for profit) organisations. This qualification will support the sector to overcome significant skills gaps as nearly one in five members of the workforce (18%) has no qualifications (UKCES, 2012).

### Funding outside of the Apprenticeship

The profile of the waste and resource management sector is such that many learners will be precluded from undertaking full apprenticeships due to an inability to meet all required elements of the framework; such as functional skills. Skills gaps identified by UKCES (2012) suggest that more than two thirds (69%) of the workforce holds a level 2 as their highest qualification. However, as a standalone qualification this provides required industry specific underpinning knowledge to support employment and professionalism within the waste and resource management sector. Learners who are unable to participate in apprenticeship frameworks should still be offered the chance to achieve vocational qualifications that improve their opportunities for career development in the future.
